## 2. Assignment overview

The volunteer will collaboratively work with PIP and its Digital Communications and Marketing Advisor to develop and implement cost-effective strategies for financing PIP's outreach services. The funds raised will be used to produce and circulate living and learning resources for the sustainable forestry sector. This is a great opportunity for someone interested in using their knowledge, skills, and experience to assist PIP to continue to make a meaningful difference in the lives of the people.

## 3. Goal/outcomes/outputs

#### Goal

To support and strengthen PIP's online fundraising capacity by providing specialist knowledge, strategic guidance and operational support in the development and implementation of successful online fundraising programs and activities that assist PIP to achieve its outreach goals.

## Outcome 1

PIP's online fundraising capacity is strengthened with new capabilities that ensure the ongoing management of successful online fundraising programs and activities. The Online Fundraising Advisor will:



- Lead the development of PIP's online fundraising strategy for delivering outreach services (e.g. target audiences, fundraising objectives, networks, platforms, content and future trends).
- Guide and support online fundraising programs and activities that secure the funds needed for PIP's recurrent outreach expenses (e.g. staff salaries and advertising fees).
- Guide and support online fundraising programs and activities that secure the funds needed for specific outreach activities (e.g. set-up community schools to access and utilise the Forest Learners Kit).
- Guide and support the ongoing appraisal of fundraising performance (e.g. produce quarterly reports that monitor, evaluate and enhance fundraising returns).

## 4. Reporting and working relationships and capacity building

This is an e-volunteer (e-vol) position. The volunteer will primarily communicate and work closely with PIP's Managing Director, Outreach Manager, and Digital Communications and Marketing Advisor. It is expected that the volunteer will collaboratively and constructively engage and work with other staff members and PIP's stakeholders to achieve desired outcomes for PIP.

The volunteer will report directly to PIP's Managing Director. While the volunteer will predominately work with the Outreach Manager and the Outreach Partners, the volunteer is encouraged to contribute to identifying capacity and capability gaps at an individual and organisational level and assist with addressing these gaps through training, mentorship, and coaching.

The volunteer and PIP will have an ongoing relationship with the VSA Programme Manager in terms of assignment monitoring, reporting, professional advice and personal support.

As needs on the ground may change over time, the volunteer is encouraged to review and update the Assignment Description in consultation with the partner organisation and VSA Programme Manager. By their very nature, development situations can involve significant change, so it is advisable that the volunteer periodically reviews and reflects on the Assignment Description throughout the Assignment to ensure the best development outcomes are being achieved.
